SWFLHCC Trainings & Exercises Task Force Meeting

Brian Massey goes through the State required trainings and exercises (*See presentation*)

Medical Response Surge Exercise (MRSE) – Planned for April. The first working group met on 10-25-23 and discussed possible scenarios and looking at the primary area to be in the rural counties. Jennifer and Robert stated that we need clear set of objectives. A poll was sent out to determine next meeting and when to hold exercise.

Crisis Standard of Care – Planned for December 12 with All Clear TTX and looking at 3 different modules that would have impact here in SWFL.

Chemical Surge Exercise – Chemical Surge Annex was completed and approved with amendments made by Executive Council and submitted to All Clear to work to design the exercise. We are looking at a possible statewide exercise with some of the other coalitions.

Pediatric Surge Exercise - Planned for March and based on the required Pediatric Surge Annex. This will be in collaboration with the Pediatric Task force and the Pediatric Clinical Advisor, Niki Shimko. Brian and Niki are finishing up an updated Pediatric Surge Annex

All Clear will be conducting Operation Evacuation: A Discussion-Based Exercise on November 7th from 9:00am to 2:00pm. This will involve a no notice or low notice event and how organizations would handle one looking at plans and procedures.
